Q&A ~ Your questions answered

When will the noisy part of the works be finished?

The contractors have now removed the crane, and there are two major outdoor tasks that should be finished by the end of July: installing a tank under the courtyard area and connecting the waste into the sewage system.

By August there should be fewer vehicles arriving and leaving, and less noise on site.

Will the dirt and dust be cleaned up?

A number of people have raised a concern about the amount of dirt and dust accumulating in Bertram Street, and we've taken this issue up with the contractor. As a result, more frequent street cleaning has been taking place.

The contractors are also currently offering to clean the windows of anyone in a Bertram Street property. Get in touch with Farrans at their site office to get your windows cleaned.

Why have only a limited number of people living around the site received compensation?

The people in receipt of payment are those that have a 'party wall' arrangement with the developer - in this case Camden council.

A party wall award is triggered where we are building immediately adjacent (up against) somebody else's property and interfering with their freehold ownership.

The party wall arrangements are a statutory requirement and have to be determined by a party wall surveyor. The payments made are not compensation for general disturbance to the neighbouring area.

Will damage caused to pavements and buildings be repaired?

The buildings around Bertram Street were surveyed before the work started and will be surveyed again when the project finishes. This means we should be able to identify any damage directly caused by the works and the contractors.

The contractor can be held liable for the cost of damage, or required to carry out repairs, for any damage that is shown to be caused by them.



What about accommodation for key workers in Camden?

Camden Living is an innovative model set up by Camden Council to help build sustainable communities and widen housing opportunities in Camden. It provides high quality genuinely affordable housing.

Camden Living Rent is designed to be a fair rent – 50% lower than market rents. It's for Camden residents and workers including people finding it difficult to stay in neighbourhoods they grew up in and people who bring added value to our borough such as teachers, nurses and key workers.

It is especially aimed at households earning around the range of £30,000 to £40,000 per year. We also welcome interest from individuals earning around £30,000 to £40,000 per annum and who want to share our homes.

Camden Living currently owns around 150 homes. In the next few years we expect to have another 300 homes to let, created by the Community Investment Programme (CIP). Visit www.camden.gov.uk/camden-living

Welcome to the neighbourhood

In January 2023, Camden council signed up to the Camden Pledge.

This commits Camden to be part of a Londonwide initiative to ensure homeless refugee households trapped in temporary hotel or hostel rooms are offered decent places to live.

A number of Afghan families currently live in temporary accommodation based in Camden, with their children attending Camden schools.

Funding for refugee settlement provided by the Home Office has enabled Camden to take the homes being built at Highgate Newtown off the market. Instead, the properties will be retained by Camden in order to provide homes for the refugees. This means more affordable housing for rent becoming part of Camden's housing stock in the longer term.

Camden officers in the Refugee Settlement team are working closely with the families to prepare them for a move into Camden homes and neighbourhoods.

A small block of seven 1 and 2 bed flats suitable for key workers was included in the Highgate Newtown development. These will also now become homes for refugees, but key workers have not been forgotten.

As mentioned opposite, many additional 'Camden Living' flats are under construction across the borough.

The majority of the intermediate rent flats created in this way by CIP go to key workers.

The new development takes shape

The new shape of the Highgate Newtown development has emerged from behind the scaffolding. The crane that dominated the central courtyard area has now gone.

It's been a long time coming. Longer than anyone would have liked or hoped. Works are still continuing to the courtyard and the internal fit out of the residential units is well underway. There's still a lot of checks, snagging, clearing up and cleaning ahead.

Highgate Newtown Community Partners (HNCP) has been fundraising for a high specification fit out. This will make the inside of the centre a truly special space, welcoming for everyone in the community. Once building work is complete and the services safely installed, HNCP will take possession and create their amazing interior 'look and feel'.

Camden's Youth services will be based on the third floor, and Camden's Early Years' service are moving onto the second floor. All of the 41 residential units on site are being retained by Camden so that Camden-based refugees can be offered a home.
